

RESOLUTION NO. _____

A RESOLUTION TO AUTHORIZE AN AGREEMENT BETWEEN THE CITY OF FITZGERALD AND THE BOARD OF COMMISSIONERS OF BEN HILL COUNTY, GEORGIA, TO FUND THE DEPARTMENT OF LEISURE SERVICES; TO PROVIDE FOR AN EFFECTIVE DATE, TO PROVIDE FOR SEVERABILITY; TO REPEAL INCONSISTENT ORDINANCES AND PARTS OF ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, the City of Fitzgerald, Georgia (the "City") and Ben Hill County, Georgia (the "County") participate jointly in funding the Department of Leisure Services ("DLS"); and

WHEREAS, adequate funding for the operation of DLS, including funding for operating the swimming pool facility for the 2020 season, is not currently in place; and

WHEREAS, the City and the County desire to roll back/reduce the DLS participation fees, and

NOW THEREFORE, BE IT RESOLVED by the Chairman and the Board of Commissioners of Ben Hill County, Georgia as follows:

SECTION 1: The Board of Commissioners of Ben Hill County, Georgia are hereby authorized to execute on behalf of said County an Intergovernmental Agreement with the Council of the City of Fitzgerald, Georgia, which such agreement shall provide for additional funding from the City and County to facilitate the Department of Leisure Services for 2020, which shall include operating the swimming pool facility for the 2020 season, as well as to reduce DLS participation fees. Said additional funding shall total Forty-Seven Thousand Five Hundred and no/100 dollars (\$47,500.00). Said funding shall be allocated equally between the City and County with the each said entity contributing Twenty-Three Thousand Seven Hundred Fifty and no/100 dollars (\$23,750.00). Said rollback/reduction in DLS participation fees shall total \$11,000.00. Funding for said rollback/reduction in DLS participation fees shall be allocated equally between the City and County with each said entity contributing Five-Thousand Five Hundred and no/100 Dollars. (\$5,500.00).

SECTION 2: Effective date. This resolution shall become effective immediately upon its final approval.

SECTION 3: Severability. In the event any provision or portion of this resolution shall be unconstitutional or invalid, the remaining portion shall remain in full force.

SECTION 4: Repeal of inconsistent resolutions. Any portion of any resolution in conflict with his resolution is hereby repealed.
