



Scope of Work

Introduction

Ben Hill County is in need of a VTC upgrade/addition to the existing Courtroom AV system. This system will allow for holding Virtual Court and First Appearance by Video as well as providing a Livestream solution to satisfy the requirements of Open Court laws. The VTC system will integrate with existing Audio-Visual systems installed by S&L Integrated.

Proposed work to be done

To meet the client's requirements as described above, we propose to install a total of 5 new cameras in the Courtroom. Four (4) of the cameras are dedicated to Video teleconferencing (VTC) while the 5th camera is dedicated to the Live stream system for Open Court requirements. The VTC solution uses four (4) cameras that will capture the Judge's Bench, Witness Stand, Prosecution and Defense Tables. We will provide and install a multiplexer to allow the four cameras to be digitally stitched together for one (1) image so that remote parties can see all participants from the Courtroom in a single view. Video from each camera will feed into the multiplexer via Serial Digital Interface (SDI). Power for each camera will be extended with the SDI signal via RG6 Siamese cabling. Audio from the Courtroom will be directly fed from the digital signal processor (DSP) to capture existing microphones. Due to the expansion of the new system, the existing DSP hardware will be upgraded to a newer model with sufficient processing power. Both the Audio and Video feeds will connect to a Web Presenter module which combines the signals. The Web Presenter will connect to an Owner Furnished (OFE) PC or Laptop using USB cable. The OFE computer will run a "soft codec" application for VTC. Soft codec applications can include Starleaf, Zoom, WebEx, Lifesize or others if approved and configured by S&L Integrated. We will provide a Video feed via HDMI from the OFE PC or laptop to existing displays in the Courtroom to allow people in the Courtroom to view the Video teleconference. Audio from the OFE PC or Laptop will be de-embedded and returned to existing DSP to allow the Courtroom participants to hear the remote participants.

To satisfy the requirements of Open Court, S&L will provide and install a 5th camera that will capture the overall Courtroom from the Gallery. The camera will supply video via SDI. Audio will be captured from the existing DSP. Both Audio and Video will feed into a professional video streaming and recording appliance. This device will connect to the OFE Network for access to the Internet to provide live content to CDNs (content delivery networks) such as YouTube, Facebook Live, and Ustream.

S&L responsibilities and deliverables

S&L will supply and install the audiovisual equipment. We will program, test, and commission the equipment.

S&L will deliver a full set of location/detail drawing as-builts as well as product manuals and a quick start user guide in either paper or electronic form, per client's preference, upon project completion.

S&L will work with customer in regards to installation of any electrical requirements for this system, however we will provide power specifications and locations where required.

S&L is not responsible for providing any end user devices to be displayed through system.
