FY 2022 Proposed Budget

County Manager Michael Dinnerman presented a balance budget to the Commissioners and the public in the amount of \$10,630,290. He stated the \$720,000 increase is attributed to salaries and benefits. The increase is based on the salary study that was conducted several years ago. We also had an increase in fuel, IT, attorney fees and COVID. We will recoup some of the COVID money back through GEMA for FY 2020 and 2021.

Mr. Dinnerman commended CFO Darlow Maxwell for his work preparing the budget.

MOU Resolution/National Prescription Opioid

Vice-Chair Hope Harmon made a motion to adopt the MOU Resolution between the State of Georgia and certain local government entities concerning the national distributor and J&J Settlements and directing the execution of the acknowledging and agreement for a collective \$26 billion and appointing County Manager Michael Dinnerman as the duly appointed representative for the County. Commissioner Bennie Calloway seconded the motion; which passed with Vice-Chair Hope Harmon, Commissioner Bennie Calloway, Commissioner Daniel Cowan, and Chairman Steve Taylor all voting for the motion.
