- We have some expenses due to COVID-19 and we have some lost in revenue in our Court System.

USDA Grants & Loans Ratify

Commissioner Daniel Cowan made a motion to ratify the vote to accept the Direct Facilities loan not to exceed \$108,000 with an interest rate of 2.25% and a Disaster Relief grant not to exceed \$100,000 to purchase a wheel loader and tractor to be used by the county Road Department. Vice-Chair Hope Harmon seconded the motion; which passed with Commissioner Daniel Cowan, Vice-Chair Hope Harmon, Chairman Steve Taylor, and Commissioner Bennie Calloway all voting for the motion.

Vice-Chair Hope Harmon made a motion to ratify the vote to accept the Direct Facilities loan not to exceed \$410,000 with an interest rate of 2.25% and a Disaster Relief grant not to exceed \$100,000 to purchase two road graders to be used by the county Road Department. Commissioner Daniel Cowan seconded the motion; which passed with Vice-Chair Hope Harmon, Commissioner Daniel Cowan, Chairman Steve Taylor, and Commissioner Bennie Calloway all voting for the motion.

Vice-Chair Hope Harmon made a motion to ratify the vote to accept the Direct Facilities loan not to exceed \$155,100 with an interest rate of 2.25% and a Disaster Relief grant not to exceed \$100,000 to purchase five trucks, a mower, a trailer, and a welder to be used by the county Road Department. Commissioner Daniel Cowan seconded the motion; which passed with Vice-Chair Hope Harmon, Commissioner Daniel Cowan, Chairman Steve Taylor, and Commissioner Bennie Calloway all voting for the motion.

Vice-Chair Hope Harmon made a motion to ratify the vote to accept the Direct Facilities loan not to exceed \$172,500 with an interest rate of 2.25% and a Disaster Relief grant not to exceed \$100,000 to purchase a tractor and backhoe to be used by the county Road Department. Commissioner Daniel Cowan seconded the motion; which passed with Vice-Chair Hope Harmon, Commissioner Daniel Cowan, Chairman Steve Taylor, and Commissioner Bennie Calloway all voting for the motion.
