Approval of the Agenda

FY 2025 Proposed Budget

Chairman Steve Taylor stated that a public hearing was held on December 3rd, 2024, to present the public with the proposed budget in the amount of \$11,999,917 for revenue and expenditures.

Vice-Chair Hope Harmon made a motion to adopt FY 2025 proposed budget as presented in the amount of \$11,999,917 in revenue and expenditures. Commissioner Bennie Calloway seconded the motion, which passed with Vice-Chair Hope Harmon, Commissioner Bennie Calloway, Commissioner John Mooney, and Chairman Steve Taylor all voting for the motion.

Commissioner Daniel Cowan voted Nay on the motion.

Hazard Mitigation Plan

Chairman Steve Taylor stated there was a Public Hearing held December 11th, 2024, at 10:00am.
